He served as a Communications/Electronics Officer and Field Artillery Officer and graduated from several Army Advanced Schools. He was a Battery Commander, Brigade Staff Officer, and Deputy Commandant of the RI Military Academy.

Steve is a proud member of ANAVICUS (Army, Navy, Air Force Veterans (Canada and US), MOFW (Military Order of Foreign Wars) and Military Order of All Wars.

In retirement, Steve dedicates much of his time to the American Legion where he is Post Commander, District Commander and Dept. Vice Commander. In June, 2020 he became Department Treasurer, overseeing all finances within the American Legion in Massachusetts. He serves on the Finance Committee for the Legion. **Patricia Ryan** retired from the U.S. Army in 2012 after nearly 30 years of service. Following four years as an enlisted Soldier, she was commissioned a Military Police Lieutenant through the RI National Guard Officer Candidate School.

Patty is a combat veteran of Desert Storm (1990-1991) and Operation Enduring Freedom (2008). She attended both the US Naval War College and the US Army War College, earning a Master's Degree from each institution.

Upon entering the Title 10 program, Patty served as the National Guard Chief of Staff at The Maneuver Support Center of Excellence at Ft. Leonard Wood, MO, and then the MP SME at the US Army Peacekeeping Institute in Carlisle, PA.

In addition to her Military Police service, she was a qualified Logistics Officer, Personnel Officer, Finance Officer, and Military Intelligence Officer.

MEMBERSHIP TYPE (Check One)

Any individual who has served at least six (6) years in the Rhode island national Guard and has completed twenty (20) years or more total military service and retired with an honorable discharge is eligible for membership with voting rights. The privilege of voting is extended to members who are currently paid annual members or honorary life members.

[] Associate Member

Anyone who is former military with an honorable discharge, or a current member of the military, or the spouse of a former or current member is eligible to become an associate member. The privilege of voting is not extended to these individuals. They may participate on committees and activities of the organization, provided their dues are paid through the current membership year (**1 October through 30 September**).

Exception: Associate military retired members who provided exceptional support to the organization for three or more years may be granted full membership with voting rights by the members during a quarterly meeting.
